VENDOR SPACE: See Application for details on vendor pricing. Booth space is 15x15 (including all wires, stakes, poles, etc.) Your roof must be able to withstand wind, rain and other inclement weather. You must secure your booth in case of windy conditions. All items being sold or displayed must be contained within booth space.

ELECTRICITY: \$50 for standard (110 volt / 20 amp). Vendors must list all electrical connections on application. Electrical arrangements must be made prior to your arrival. Last minute electrical changes will not be accepted. A limited number of spaces with above standard power needs are available on a first come first serve basis. Please call our office to check availability.

REQUIREMENTS: Vendor will be responsible to be open both days during the entire festival. **Vendors will not be allowed to leave the premises until after 10:30 PM each night**. Your booth must be neat, attractive and will-maintained. Signage with visible and clear pricing is required. You are responsible for setting up, maintaining and removing your own booth, merchandise and trash. Food Vendors are required to abide by state and local food, health and safety regulations and could be subject to inspection. Vendors using generators must have a quiet model (Honda, predator, etc) **NO FLEA MARKET OR YARD SALE ITEMS**

APPROVAL PROCESS: All applications will go before the Festival Board of Directors for approval. All vendors are required to provide a detailed description of merchandise, menu, rides/games and booth. Photos of your merchandise and vending operation are required. Incomplete applications will be automatically denied. We will not accept applications via fax or email. Full vendor fee must accompany the original application and must be submitted via mail or in person. The Board reserves the right deny any application without explanation.

VENDOR PARKING: A designated parking area will be available for vendors. ONE vendor parking pass will be sent w/ vendor acceptance letter. Additional Parking passes can be purchased for \$20 each, **LIMIT (2) TOTAL**. NO vehicle will be permitted into vendor parking without a pass. Vendors will receive 2 complimentary vendor wristbands that MUST be worn at all times. Additional wristbands can be purchased for \$5 each.
